## **ENROLMENT ELIGIBILITY CLAIM** Nomination by Body Corporate

FORM 2D Regulation 11A of the Local Government (Elections) Regulations 1997

Under section 4.32(2) of the Local Government Act 1995 (the Act), you may nominate up to 2 persons to vote for your body corporate using his form at any time. However, if you want to be on the roll for a particular election, you must give your claim form to the local government more than 57 days before the election date.

You should fill in this form if your body corporate wants your nominees to vote at local government elections for that district and you:

- x Own or occupy rateable property in a district or ward; and
- x The nominees are not on the residents roll in that district or ward.

To qualify as an occupier, your body corporate must:

- 1. Have a right, under a lease, tenancy agreement or other legal instrument, to be continuous occupation of a rateable property in the local government district for at least the last 12 months.
- 2. Have a right, under a lease, tenancy agreement or other legal instrument, to be in continuous occupation of the property for at least the next 3 months.

The occupied property must also comply with minimum standards set in the Act and Local Government (Elections) Regulation 1997. If you are an occupier and your enrolment eligibility claim is accepted, it will expire in accordance with section 4.33 of the Act (usually 6 months after the second ordinary election after your claim was accepted) or when your lease expires. If you wish to continue to qualify as an elector after that, you will need to make another enrolment claim and nomination.

Attach this form when you are claiming enrolment eligibility as the nominee of a body corporate alongside either Form 2A or Form 2B.
